MINUTES REGULAR BOARD MEETING February 6, 2012

The meeting was called to order at 7:00 p.m. by Board President, Ms. Davel. Report on WASB Convention

Ms. Pufahl, Mr. Balsiger, Ms. Ives and Ms. Levzow each talked about the workshops they attended at the WASB Annual Convention in January. The workshops included Upgrading Facilities in Challenging Times and Tight Budgets, Employment Relations, Common Core Standards, Effective Digital Tools for Instruction, The Ins and Outs of Federal Funds, Long-Term Strategic Impact of Health Care Reform, WASB Employment Relations, Legislative Issues, Funding Schools in Wisconsin and the general session with speaker Will Richardson.

Report on January Pupil Count

The number of students attending school in the Pardeeville Area School District during the January pupil count was 839 in all grades. The number remained the same as the September count and is pretty consistent with the previous school year's numbers.

Referendum Update

Referendum informational meetings will be held on Monday, 3/12/12 at 7:00 p.m. in the high school library, Thursday, 3/22/12 at 7:00 p.m. in the Wyocena Community Room and on Tuesday, 3/27/12 at 7:00 p.m. at the Marcellon Town Hall. Walk-thru tours will also be held on two Saturdays—March 24 and March 31. The tours will begin at 9:00 a.m. in the high school building and will then go to the Balliet building and elementary school.

Petition to Alter School District Boundaries

Mr. Knitt informed the school board members that a petition to alter school district boundaries was received on January 31, 2012 from Lynn and Jan Bradley who are petitioning to have their property in the Pardeeville School District become part of the Cambria-Friesland School District. Mr. Knitt said a formal hearing and a board decision will be part of the February 20th meeting. If both school districts agree, the matter will be over and the change will become effective July 1, 2012. If one district says no, the property owner can appeal the decision.

Approval of Minutes Dated 1/16/12

A motion was made by Ms. Pufahl to approve the minutes dated 1/16/12 as presented. The motion was seconded by Mr. Skaar. Motion carried 7-0.

Approval of Coach for Pardeeville Students Participating in Wisconsin State High School Ice Fishing Championship

A reminder from the school board was made to be certain proper parent permission, etc. is in place. The board members also expressed an interest in having one of the students report back to the Board about their experience from this event.
